

**AGREEMENT FOR VOLUTEER AND/OR DONATED GOODS AND SERVICES
(where special trade or license, or permit is required to perform work)**

THIS AGREEMENT, entered into this _____ day of _____ (herein referred to as the anniversary date) by and between the LAFOURCHE PARISH SCHOOL BOARD, (hereinafter called "School Board") and _____, (hereinafter called "Volunteer/Donor").

WHEREAS, _____ does hereby wish to donate certain materials and services to the Lafourche Parish School Board and said donation shall include capital improvements to property and/or structures owned by the Lafourche Parish School Board;

WHEREAS, the School Board does hereby wish to conditionally accept the donation, subject to the minimal terms and conditions herein stipulated;

ACCORDINGLY, Donor does hereby donate the following:

"SCOPE OF WORK TO BE DONATED"

The Lafourche Parish School Board, appearing through its Superintendent and pursuant to School Board approval does hereby accept the donated materials and services described above, and subject to the following conditions:

- a. The above scope of work shall be approved by a design professional or by LPSB personnel prior to the commencement of the Work.
- b. Donor shall secure all required building and occupancy permits;
- c. Donor shall maintain comprehensive liability insurance and workers compensation insurance which shall be in force and effect for the scope of work. The minimum policy requirements are as follows (unless reduced or waived by the LPSB by addendum to this Agreement): The reduced insurance requirements are:
 1. Commercial General Liability with limit reduced to \$500,000 per Occurrence, \$1,000,000 Aggregate. This policy must include BI-PD, personal injury, products, completed operations and contractual liability. It must add LPSB as an Additional Insured. It must Waive Subrogation in favor of LPSB.
 2. Business Auto Liability with limit reduced to \$500,000 per Occurrence and Waive Subrogation in favor of LPSB.
 3. Workers Compensation with Coverage A – Louisiana statutory benefits and Coverage B - \$1,000,000 each accident, \$1,000,000 each sickness and \$1,000,000 sickness aggregate. Policy must Waive Subrogation.
- d. Donor shall and does hereby agree to indemnify, defend and hold the School Board, its agents and assigns, harmless from any and all liability associated with the scope of work, penalties and reasonable attorney's fees, as a result of injuries to or death of persons, damage to property of any kind, pollution or other damage to the

environment or the violation of any law, rule or regulation, arising wholly or partially out of or in connection with or resulting from donated scope of work only.
